



Floyd Makers Market - 2026 Vendor Application

Thank you for applying to be a vendor at the Floyd Makers Market. The Market will take place from **9 AM to 2 PM on the 3rd Saturday of each month from June - October** and will be located on Jacksonville Circle (the road between the Floyd County Courthouse and Floyd County Administration Building). Questions and completed applications must be sent to Tourismdirector@visitfloydva.com or dropped off at 203 East Oxford Street, Floyd, VA 24091.

Once your application is submitted, it will be reviewed, and the Tourism Director will reach out to you for confirmation and vendor fee payment options.

Vendor Fees

- **\$25 nonrefundable fee per market day for a 10ft x10ft space**
- Fees are due once your application has been approved and confirmed
- Vendors who sign up for **all five market dates** will receive a **\$20 discount (total cost \$105)**
- Vendors are encouraged, but **not required**, to attend all market dates

Setup & Logistics

- Setup begins at **8:00 AM** on the day of the market
- All vendors must be fully set up by **9:00 AM**
- Vendors will be placed on both sides of Jacksonville Circle
- Spaces will be assigned upon arrival, working backwards from Main Street
- Vehicles will be allowed in the event area for set-up, but must be moved to the parking lot prior to **8:45 AM**.
- Vendors must remain set up until **2:00 PM**, **vehicles will not be allowed to enter for loading until after the market closes**

Vendor Responsibilities

- Vendors must provide their own **tables, chairs, tents, and display materials**
- Vendors are responsible for the setup and breakdown of their space
- Vendors must keep their area clean and free of trash
- Floyd Tourism, County of Floyd, and Town of Floyd are **not responsible** for any damage, loss, or theft of vendor products, displays, or personal property.
- Vendors are required to have a valid business license for the Town of Floyd. An annual business license, valid for the 2026 calendar year, is available for \$30, and the application can be found [here](#). A Special Event License (SEL) is available for \$10; however, it is only valid for one day. The application for the SEL can also be found [here](#).

Weather Policy

- The market is a **rain or shine event**
- In the case of **severe weather**, as determined by the Floyd County Emergency Department and/or Floyd Tourism, the event will be canceled
- If canceled due to severe weather, **vendor fees will be refunded**
